



Day Care Rules

1. Dogs must be at least 12 weeks of age
2. Dogs are required to come for a full day trial evaluation. This is free of charge.
Typical reasons dogs fail are:
 - a. Aggressive behavior
 - b. Excessive mounting
 - c. Biting other dogs
 - d. Biting staff
 - e. Severe medical problems
 - f. If we feel it's not a good fit
3. Dogs must have vaccinations including rabies, DHLPP (distemper) and be current with their Bordetella (kennel cough) vaccination. This vaccine requires two boosters annually and most veterinarians only administer this when specifically asked
4. Dogs over nine months of age must be spayed or neutered unless there is a medical condition that prevents the procedure from being performed (retained testicle, etc.) Do not call if your dog does not meet these criteria.
5. Dogs must be in general good health.
6. We need the waiver, the application and a copy of your vaccination records. You can have the vet email them directly to us at info@bffpetcare.com. We need all of this information no later than the trial day.

Cancellation Policy

If you need to cancel just call us to let us know. There is no penalty as long as we get a phone call. If there is no call and no show, a day will be deducted from your package.

Day care must be paid in advance. We take cash, check and all major credit cards.

If for some reason your dog is not able to attend day care, and depending on your needs, we may be able to arrange for in-home pet sitting.

I understand and agree that in admitting my dog to Best Friends Forever Pet Care LLC that the facility has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.*

I understand and agree that Best Friends Forever Pet Care LLC will not be liable for problems, damage or injury caused by my dog provided reasonable care and precautions are followed by day care staff. I understand that Best Friends Forever Pet Care LLC is full insured. I release Best Friends Forever Pet Care LLC of any liability arising from my dog's attendance and participation at the day care. I understand that the day care is a place where animals co-mingle in groups. I understand my animal may be placed in a crate for "time outs" not to exceed twenty minutes or if injured. Squirt water bottles are used for correction. In extreme cases, dogs may be muzzled for their protection or the protection of others or for excessive barking. I understand that when dogs play in groups, nicks and scratches may occur. Day care staff may or may not notify me immediately. If the injury is not serious, staff may feel it is ok to leave the dog till the end of the day let me know about it when I pick up. If the injury is serious, I will be notified immediately.*

_____ 3. I understand and agree that any problem or injury that develops with my dog will be treated as deemed best by Best Friends Forever Pet Care LLC. Either my veterinarian or our mobile veterinarian will be contacted in the event of a medical problem that is serious in nature. The Department of Agriculture of Colorado requests that a plan be in place in the event that your animal was to become deceased while at the day care. I will be notified immediately of the situation and the body will be taken to Harrison Memorial Animal Hospital or will be held at your request until your arrival.*

_____ 4. I understand that if my dog is left at the day care for a period of three days without contact from the owner, this dog will be considered abandoned and necessary steps will be taken to turn the animal over to the proper authorities.*

_____ 5. I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include, but are not limited to; problems resulting from rough play, food scraps found outdoors and kennel cough (doggie colds).*

_____ 6. I agree to be solely responsible for any and all acts or behavior of my pet while in the care of Best Friends Forever Pet Care LLC. If my pet should become ill or seem to be in the need of medical consideration, Best Friends Forever Pet Care LLC reserves the right to administer aid and/or to use any available veterinarian. I shall pay any expenses that are incurred.*

_____ 7. I consent for Best Friends Forever Pet Care LLC to use products not labeled for use on pet animals, for example, if pills must be given, peanut butter may be used.*
